Spring Update

This is possibly the strangest spring we have faced in years with the advent of the COVID-19 pandemic. As you might guess, this has led to many questions as to how our District's normal spring and summer activities will be affected. At this time, we still plan to have our spring tree (limited) and trout sale, and we still plan to implement conservation projects throughout Lamoille County; whether that entails best management practices for lakeshore properties, nutrient management planning for farms or green stormwater infrastructure implementation. All education programs listed for April on Pg. 5 will be postponed or cancelled if restrictions on gatherings continue through April and libraries remain closed. We recommend calling ahead before venturing out to one of our programs. All protocols as recommended by the Center for Disease Control and Prevention (CDC) and federal and state mandates will be closely followed in any field work we do.

We are going to continue our spring membership drive and fundraising activities. The considerable indirect costs associated with our work which is not covered in any grants or core funding, necessitates the need for consistent fundraising. This need is so great that we plan to hold a **Conservation Field Day and Friendraiser** on May 17th in Oxbow Park from 11am to 4pm. The event will have our conservation partners present, conservation workshops, vendors, music, and a paddle down the Lamoille to event at start of the day for those who are interested. There will also be a 50/50 raffle and silent auction. Due to the COVID-19 pandemic and the uncertainty of state and federal mandates this event may be postponed. LCCD will officially advertise the time and date of this event by April 17th. We hope to see you all there regardless of when it will be! Agriculture Programming Updates

We had a busy winter with our "Thank our Farmers for the View" art show and the launch of the Lamoille Count Farm Grocery Guide. Thanks to all that came out to the opening and checked out the show, and thank you to all of the farmers that made the project possible. New versions of the FGG will be coming out soon with updated producer info and will be made available or could be mailed. We need to support our local economy and producers now more than ever in these difficult times. Cows will continue to be milked and crops sown so that we can all be fed!

Two Lamoille County farmers went through the RCCP nutrient management program with us this winter through UVM extension and now have complete nutrient management plans to utilize this growing season. These plans help mitigate excess nutrient application, which in turn keeps our surface waters clean, and increases farm profitability and yields.

Through the state CEAP program, Lamoille County was granted funding to purchase a no-till drill this spring! We chose a 9 foot Aidchison Seedmatic, which is especially well suited for re-seeding hay fields and pastures, but can also be used for cover cropping, or planting any no-till crops such as corn, beans, and small grains. We hope that many farmers in the area will utilize the drill to reduce topsoil erosion and conserve soil carbon.

We will continue to support Lamoille County Farmers in any way we can through our various conservation programs and on-farm technical assistance. If you have any agriculture related inquiries, please contact Silene at lcdd.agoutreach@gmail.com. Happy Spring!

2020 PROJECT UPDATES

The Lake Eden Watershed Action Plan



Through an Ecosystem Restoration Program grant provided by the Vermont Department of Environmental Conservation in 2018, the Lamoille County Conservation District (LCCD) conducted a full watershed assessment of the Lake Eden watershed. LCCD contracted Fitzgerald Environmental Associates LCC and partnered with Lamoille County Planning Commission, VT Agency of Natural Resources, VT Department of Fish and Wildlife, Boy Scouts of America, Town of Eden, Lake Eden Association, US Fish and Wildlife Service, and Vermont Youth Conservation Corp (VYCC) to complete this study.

Lake Eden is a pristine lake but has been showing nutrient (i.e. Phosphorus) and sediment loading stresses due to development patterns surrounding the lake. The study assessed what locations these stressors were most impactful by conduction road erosion inventories, stream walks and shoreline assessments. LCCD worked closely with the town and lake association to identify known issues as well. 20 possible projects were identified and 5 of these that ranked highest were brought to 30% design. LCCD intends to implement best management strategies to mitigate sediment and nutrient loading at these 5 sites over the next couple years combined with continued monitoring of water quality.

Along side of this assessment The VT Agency of Natural Resources made inroads introducing the Lake Wise program to local shoreline owners. Lake Wise is a program that helps these land owners implement shoreline Best Management Practices (BMPs) for stormwater management, storm resiliency and improved wildlife habitat. Shoreline owners who score particularly well with their land stewardship will receive a certification and a sign that they can proudly display on their shoreline for their neighbors to see. While the assessment was in progress 6 BMPs were installed around the lake with the help of the VYCC and volunteers.

Stormwater Master Plans for Morristown and Hyde Park

Through an Ecosystem Restoration Program grant provided by the Vermont Department of Environmental Conservation in 2018, the Lamoille County Conservation District (LCCD) produced a Stormwater Master Plan for the towns of Morristown and Hyde parkLCCD contracted Watershed Consulting Associates LCC and partnered with the towns of Morristown and Hyde Park, the Lamoille County Planning Commission, and the VT Agency of Natural Resources, to complete this study.

The study assessed approximately 27,000 acres to determine what locations were stressed the most by sediment, pollutant and nutrient loads (specifically Phosphorus), were potential flood hazards and had the largest impact on the Lamoille River Water Basin and its tributaries. 20 possible project sites were identified and 6 of these that ranked highest were brought to 30% design. LCCD intends to implement best management strategies to mitigate sediment and nutrient loading at these 6 sites over the next couple of years combined with continued monitoring of water quality.

Lamoille Watershed Group, Aquatic Organism Passage (AOP) Steering Committee

In 2019, the Lamoille County Conservation District gathered local watershed partners to form an AOP (Aquatic Organism Passage) Steering Committee, to explore potential culvert replacement projects that would improve aquatic organism passage along streams in Lamoille County. The Steering Committee is comprised of Lamoille Watershed representatives and technical assistance providers including the U.S. Fish and Wildlife Service, Vermont Fish and Wildlife Department, Vermont Department of Environmental Conservation, Lamoille County Conservation District, and the Lamoille County Planning Commission. The objective of this Lamoille AOP Partnership Project is to identify potential AOP culvert replacement projects that will yield benefits to aquatic communities and water quality, while aiming to align these benefits with municipal infrastructure priorities. Approximately 8-10 culverts have been identified as in need of replacement or retrofit to improve Brook Trout Habitat.

Common Questions and Answers:

Will trout live in my pond? Which trout species is better for my pond?

Trout survive best in cold oxygenated water maintaining a water temperature of 65°. As long as there are springs or a source of water flowing into the pond, small ponds to large ponds will accommodate both species of trout. If waters are not consistently flowing into the pond, then the pond should be at least 8' in depth and shaded to maintain temperatures in summer and winter. Ponds that have well-oxygenated flowing waters support Brook trout best. If water warms in the summer, Rainbow trout have a higher success rate.

How many trout and how often should I stock in my pond? Should I feed the trout?

The number and size of fish depend on the water flow, chemistry, and available food source. The general rule of thumb is 100 8" trout per 1/4 acre of open surface area. If the waters are spring fed, and the temperatures are consistent then stocking once every few years may work. If there are predators such as heron, mink, or fishers present than you may want to stock annually. Large trout will feed on smaller trout that are half their size. Ponds that are older than three years should have enough aquatic insect larvae, worms, tadpoles, etc. for trout to eat. Newer ponds that lack substrate such as a vegetative buffer around the pond, and submerged and benthic plants may not support these natural foods. Feeding fish may cause an increase in nutrients to the pond which can then lead to algae.

What can I do about algae in my pond?

LCCD provides site visits for pond owners to assess pond conditions and make recommendations. Site visits are scheduled in June.

It's best to stock trout immediately in your pond after pick up to insure their survival.**

Orders of 10-12" trout will be delivered by the trout farm **any time** on the afternoons of **May 6th or May 7th**. Price per lot includes delivery. We cannot schedule deliveries. A flag at the delivery site and/or an order confirmation will be left onsite. Please e-mail or include directions to the best location to leave confirmation and specific directions from the nearest route to your pond with your order form and payment. Addresses will be mapped via Google and GPS with other deliveries. Split deliveries within one-mile include a \$30 additional charge.

Order confirmation calls or reminders are not provided. Please retain this information sheet for your records.

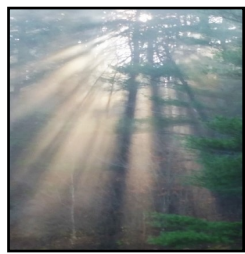

Watershed Education

LCCD continues to provide watershed education throughout the Lamoille watershed, last fall with science students at Laraway School. We look forward to more watershed lessons this spring with the sixth graders at Johnson Elementary School, thanks to funding from the Green Mountain Fund of the Vermont Community Foundation.

Winter Wildlife Outdoor Series

In January and February we brought our Winter Wildlife Series to the third graders at Wolcott Elementary School. Over four visits, we explored the frozen forest for animal tracks, burrows, and entrances to the subnivean zone beneath our feet and tried to see the challenges our wildlife neighbors face during the long cold winter.



LOOK and Discover with Stowe Kindergarten

For a second year, LCCD has been collaborating with the Stowe Elementary School kindergarten on their nature immersion program called "Learning Opportunities Outdoors with Kids (LOOK and Discover)." One Friday per month, LCCD's environmental educator joins each of the three kindergarten classes in the woods for exploration, fresh air and themed activities including mouse house construction and animal tracking. Welcome Spring Nature Playgroup

For six Wednesdays April through June we will host our nature-based playgroup at LCNC for children preschool and younger and their caregivers. 2020 will be the third year of this program, which has brought 153 visitors to the nature center to enjoy the sights, sounds and smells of spring, rain or shine!

Lake Champlain Basin Program Funds Lamoille Watershed Investigation Series

LCCD will offer a six-part lesson series focused on the Lamoille watershed and its place in the Lake Champlain Basin to four 3rd-6th grade classrooms in Fall 2020. Activities will include mapping, modeling, water quality testing and field surveys. We are looking for interested, adventurous teachers at Wolcott, Johnson, Cambridge and Waterville. This project is funded by an Education and Outreach Grant from the Lake Champlain Basin Program.

Vermont Envirothon

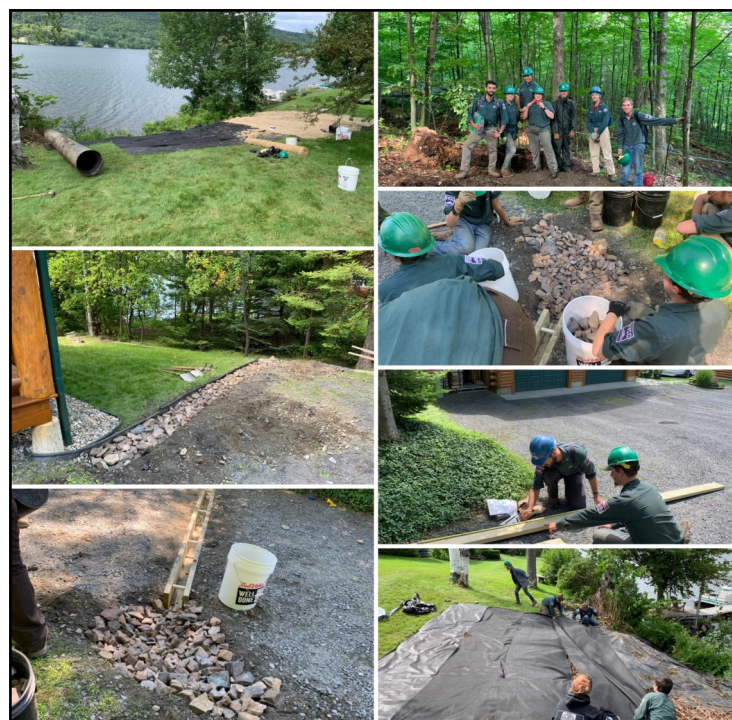
